## Terms & Conditions of the Swissquote Bank Ltd Forex referral program

By referring someone or by being referred, you agree to the terms and conditions of the program as defined by Swissquote Bank Ltd.

### **Conditions of the program**

- The referrer and the referred client benefit from a Referral Bonus on their Forex accounts.
- The Referral Bonus will only be awarded if all the following conditions are met:
  - **1**. The account opened by the referred client must be a Forex account with a minimum deposit of CHF 5'000.
  - 2. For the referral to be valid, the referrer's promotional code must be indicated in the account submission form.
  - The account opening documents of the referred client (including a certified true copy of an identity document) must be sent to Swissquote Bank Ltd, duly completed and signed.
- The Referral Bonus is credited on both referrer and referred Forex accounts once the referred traded at least 1 lot.

- No correspondence will be entered into regarding this program. No legal recourse is possible.

By participating to the program, the referrer and the referred client consent that both parties will be informed directly or indirectly of the opening of accounts with Swissquote Bank Ltd, and of some deposits and trading activities related to the fulfilment of conditions of the program.

#### **Referral Bonus**

The Referral Bonus is a virtual amount of a variable value, available on the Forex account. When an electronic transaction is made, fees and commissions relating to the transaction will be automatically deducted from the available Referral Bonus.

The Referral Bonus cannot be returned, exchanged or converted into cash and is valid for a limited period only. It will be removed from the account on its expiry, even if it has not been entirely used.
